

ASPT Limited Warranty

Subject to the terms and conditions of this limited warranty, Air Showers and Pass Thrus Unlimited Inc. ("ASPT") extends coverage against manufacturing defects for the product(s) identified below that are installed in the United States, Canada and Mexico.

Products: Air Showers, Pass Thrus

This limited warranty applies to products manufactured on or after January 1, 2014. All repairs of product parts covered under this limited warranty must be made with authorized service parts by a qualified service provider.

Term: The limited warranty period for product(s) shall commence from completion of installation or a maximum of 90 days from ship date for 12 consecutive months.

Who is covered: This limited warranty is only valid at the original installation site and is non-transferable. ASPT has the right to request any and all proof of product(s) purchase or installation and/or completion date of installation.

What is covered: ASPT will provide a replacement part to the qualified service provider or end user free of charge, if product component fails due to a manufacturing defect under normal use and maintenance. *If outside the United States the purchaser must pay for any and all shipping and handling charges as well as any and all taxes and duties.* If product part is not available, ASPT will provide a suitable substitute. This limited warranty does not cover labor for removal or replacement of part or component.

Eligibility Requirements: Product(s) must be properly installed, operated, and in accordance with the product specifications and operation manual service guidelines. Failure to conform to such specifications and/or instructions will void this limited warranty. ASPT may request written documentation showing the proper preventative maintenance.

Exclusions: Labor costs including but not limited to cost of removal and reinstallation of product(s) and/or product parts, shipping and freight (*if outside of the United States*), taxes and/or duties associated with local tax authorities, failures, defects or damages (including, but not limited to, any loss of data or property caused by any third party product, service or system connected or used in conjunction with the product.) Any use that is not designed or intended for the product(s). Modification, alteration, abuse, misuse, negligence or accident. Improper storage, installation, maintenance or operation including, but not limited to, operation of electrical equipment at voltages other than the range specified on the product model number nameplate or using a wood fabricated product in a high moisture environment. Any use in violation of written instructions or specifications provided by ASPT. Any acts of God including, but not limited to, fire, water, storms, lightning, earthquakes, any theft, riots, exposure to a corrosive atmosphere or contact with corrosive materials such as, but not limited to, chlorine, fluorine, salt, sulfur, recycled waste water, rust or other damaging substances or chemicals.

This limited warranty does not cover normal maintenance parts required as described in the O&M manual for the product(s).

Additional Terms: This limited warranty and liability set forth herein are in lieu of all other warranties and liabilities, whether in contract or in negligence, express or implied, in law or in fact. The implied warranties of merchantability and fitness for a particular purpose are limited to the duration of the applicable product warranty. ASPT does not authorize any person to create for it any obligation or liability in connection with the products. Notwithstanding anything in this limited warranty to the contrary, company shall not be liable for any incidental, consequential, indirect, special and/or punitive damages, whether based on contract, warranty, tort (including, but not limited to, strict liability or negligence), patent infringement, or otherwise, even if advised of the possibility of such damages. ASPT's maximum liability hereunder is limited to the original purchase price of the products.

No action arising out of any claimed breach of this limited warranty may be brought by purchaser more than one (1) year after the cause of action has arisen. This limited warranty gives you specific legal rights, and you may also have other rights as otherwise permitted by law.
